

2025 Fee relief declaration form

Start Strong for Community Preschools

Families with children who are at least 3 years old on or before 31 July 2025, and who are enrolled at an eligible community preschool (**Service**) may save up to \$4,347 in 2025. This fee relief is provided through the NSW Government's Start Strong for Community Preschools program.

Privacy notice

The NSW Department of Education (the **department**) is committed to protecting the privacy of your personal information in accordance with the *Privacy and Personal Information Protection Act* 1998 (NSW) (PPIP Act) and *Privacy Act* 1988 (Cth).

In this declaration form, the department is collecting personal information about you and your child. This includes your child's name, sex, date of birth, address and preschool(s) attendance information and your name. You do not have to provide this personal information but if you do not then the Service will not be able to reduce your fees using fee relief under the department's program.

The department uses this information for the purpose of administering the Start Strong for Community Preschools program, including assessing eligibility, managing payments, auditing compliance, and evaluating the program and use of funding. The department may also use this information for the purpose of research and data analysis, and policy and program development in connection with the early childhood education and care sector.

The information may be used within the department or by third parties engaged by the department. If information is provided to third parties engaged by the department, the department will require them to only use the information for those purposes and reporting to the department.

The department will not disclose your personal information to any other person unless authorised by law, or with your consent. The department may publish material (for example, insights from the declaration forms), however any such information will be de-identified.

Personal information will be held and managed by the department in accordance with the PPIP Act and Privacy Act, and subject to the department's privacy policy: education.nsw.gov.au/rights-and-accountability/privacy.

Once personal information has been provided, you may also withdraw your consent at any time by contacting the Service, and no further personal information will be disclosed by the Service. However, this also means no fee relief from that point will be provided.
